#### **Residential:**

#### **Pre-wiring:**

- New construction: \$400 incentive for pre-wiring for a 240-volt, minimum 32 amp circuit.
- Existing construction: Incentive is 100% of costs (maximum of \$600) for pre-wiring a 240-volt, minimum 32-amp circuit.

#### **Residential Charging Station:**

- Incentive will be limited to 50% of the purchase price, with a \$500 maximum.
- Any residential electric vehicle charging station qualifies.

#### **Commercial:**

#### **Commercial Charging Station:**

- Direct Current Fast Chargers (DCFC) must be preapproved before equipment is ordered.
- Charging stations must be available for public use 24/7.
- DCFC: Limit of one per business location (50 kW minimum rated charging capacity).
- Level 2 charging stations: Up to four per business location.
- Not available for National Electric Vehicle Infrastructure (NEVI) chargers.

#### For Non-Profit Organizations:

- 90% reimbursement for the installation of an EV charging station. (maximum of \$1,000/kW of charger capacity)
- Grants, discounts, etc., are deducted to determine customer's cost. (total maximum incentive of \$150,000)
- Incentive is based on the lower of two qualified bids.

#### For All Other Businesses:

- \$200/kW of charging station capacity (maximum of \$30,000 on DCFC)
- Incentive is capped at 50% of charging station cost.

#### **Commercial Charging Station Conduit:**

- \$15/foot of conduit installed.
- Minimum incentive of \$500, maximum of \$2,000.
  - For new construction only.

#### **EV Promotional Events:**

- 100% reimbursement of event expenses (up to \$2,000) associated with an EV event.
  - Primary focus must be the promotion of EVs (i.e., ride and drive events, dealership promotion of new EV models, home shows, etc.).

### Follow these easy steps

- Visit with your electrical utility to discuss your EV and charging needs and pick up an application form.
- Some programs require pre-approval prior to purchase and/or installation.
- Incentives may have a limited time for purchase and/or install, which can expire.
- Once approved, there will be a time period to provide proof of purchase or installation.
- Submit payment request after purchase and installation.
